Roger Gros is publisher of *Global Gaming Business*, the industry's leading gaming trade publication, and all its related publications. Prior to joining Global Gaming Business, Gros was president of Inlet Communications, an independent consulting firm, and owner of iGamingPlayer.com, an affiliate marketing site for online gaming. He was vice president of Casino Journal Publishing Group from 1984-2000, and held virtually every editorial title during his tenure. Gros was editor of *Casino Journal*, the *National Gaming Summary* and the *Atlantic City Insider*, and was the founding editor of *Casino Player* magazine. He was a co-founder of the American Gaming Summit and the Southern Gaming Summit conferences and trade shows.

He is the author of the best-selling book, "How to Win at Casino Gambling" (Carlton Books, 1995), now in its fourth edition. Gros was named "Businessman of the Year" for 1998 by the Greater Atlantic City Chamber of Commerce, and received the Lifetime Achievement in Communications Award from the American Gaming Association in 2012.

Starting as an owner of leading gaming consumer portal from '95-'99, she then launched River City Group, which produced the largest i-gaming events in the world (GIGSE and EiG) as well as key industry trade publications, such as *iGamingNews.com* and the *Internet Gambling Report*. In July, '06, River City Group was purchased by Clarion Events, one of the UK's largest event producers, and Schneider remained as CEO/Americas there until June '09.

She recently became VP Strategy & Growth/Americas for Sports Betting Communities (<a href="www.sbcevents.com">www.sbcevents.com</a>) on their efforts to launch a sports betting show in the US. Until September, 2019, she served as Editor-in-Chief for Liebert Publications' *Gaming Law Review*. Until 2016, she was a partner with the US-based conference (<a href="www.igamingnorthamerica.com">www.igamingnorthamerica.com</a>) which was sold to iGaming Business, a division of Clarion Events Gaming. She's a former partner in the <a href="www.maltaigamingseminar.com">www.maltaigamingseminar.com</a> and, in addition, works with the G2E event as a consultant for the iGaming Congress.

Schneider was a founder and served as Chairman of the 120-member Interactive Gaming Council (IGC), a trade association, from its inception in 1996 until 2004.

She is a frequent speaker at international gaming conferences and has testified to the US Senate and the US House of Representatives.







Dermot is a corporate attorney by background and education and leads approximately two hundred people worldwide with engineering groups in London and Bulgaria, supported by technology operations in Las Vegas, Nevada.

Dermot took GAN public on the NASDAQ stock exchange in May 2020 (NASDAQ: GAN) raising \$62M in expansion capital in order to cement GAN's market position as a leading player in the fast-growing U.S. Internet gambling market.
